Any registered individual(s) who fails to attend the training **MUST** return the free curriculum kit to the Ohio Commission on Fatherhood.

**Who should attend?**

If you work with fathers and want to use an evidence-based fatherhood curriculum, this training is for you. This certification training equips parent practitioners to use the evidence-based Fatherhood Development Curriculum, which has been used by agencies and practitioners in major national demonstration projects to develop successful fatherhood programs. This includes those funded by the United States Department of Health and Human Services, Office of Family Assistance from 2005-2020.

**How many from my organization may register?** No more than two from your organization may register.

**Do I need to register?** Yes. Be prepared to provide your name, organization name, email address, and the mailing address for the curriculum training packet.

**Will there be a wait list?** The Ohio Commission of Fatherhood will maintain a waitlist of interested individuals, if necessary.

**Do I need to purchase the curriculum?** No. The Ohio Commission on Fatherhood is purchasing the curriculum for the participants. Only one curriculum will be provided to each organization represented.
